General Information

The Legacy Fund is one of the best ways to leave your legacy at Newman and help future students find their faith home while in college. Your pledge will contribute to your class gift at Newman, creating a lasting impact in the lives of future college students!

Where does my money go?

Your gift will be added to the Campus Ministry endowment. Endowments work through investments. By investing large sums of money into the Campus Ministry endowment, the endowment earns interest. Newman will then draw from the interest earned to use as a part of the annual budget. The initial endowment gift continues to be invested year after year, allowing your gift to continue to impact the ministry for – literally – a lifetime!

Why should I support the class gift?

The Legacy Fund touches every area of student ministry at Newman. No matter how you were involved, your time at Newman was, in part, made possible by alumni who supported you. Our God calls us to be generous with the gifts given to us; giving of your resources is one way you can return your blessings to God.

How does it work?

You can make a pledge to the Legacy Fund today and then whenever you're ready, you can start giving with a monthly gift that will go towards that pledge. You can start, increase, decrease, or hold your gift at any time by contacting Newman.

Can I defer the start date?

Yes! Once you select your pledge amount, you will have the option of choosing a start date - either today or another future date. We ask that, to be counted towards your class gift, you start payments on your pledge by the December after your graduation.

Do I have to pay with a credit card, or can I pay by check?

You can sign up online to have your gift drawn from your credit or debit card. Or, if you wish to have your pledge drawn directly from your checking account, you can fill out an EFT (electronic funds transfer) form and send it to Newman.

What if I need to change my gift?

Your pledge is not a legally binding contract. If you need to decrease, increase, hold, or cancel your gift, you can do so at any time. While we ask for your commitment, we do understand that circumstances may change that necessitate a change in your gift.

Can I wait to pledge until I get a job?

We ask that all pledges to the Legacy Fund be made by graduation. Seniors who commit before graduation will also receive a special gift from Newman to thank you for all the ways – tangibly and intangibly – you have blessed and will continue to impact our Newman community!
