What is a Donor Advised Fund?

A Donor Advised Fund is a charitable giving account established through a sponsoring organization.

- Your contributions can be invested for potential tax-free growth.
- When you're ready, you recommend grants to qualified charities like St. John Henry Newman Catholic Church.

Step 1

Contribute cash, stocks, or other appreciated assets to your Donor Advised Fund.

Step 2

Receive an immediate charitable tax deduction (if eligible).

Step 3

Allow your charitable dollars to grow through investment.

Step 4

Recommend grants to support St. John Henry Newman Catholic Church whenever you're ready.
