What is an IRA Charitable Distribution?

If you are age 70½ or older, you may be able to make a gift directly from your Individual Retirement Account (IRA) to St. John Henry Newman Catholic Church &/or Campus Ministry through a Qualified Charitable Distribution (QCD), often called an IRA Charitable Rollover.

A QCD allows you to support the ministries you love while potentially reducing your taxable income. If you are age 73 or older and required to take Required Minimum Distributions (RMDs), a QCD can also satisfy all or part of your annual RMD.

- May reduce your taxable income
- Can satisfy your RMD
- Supports Newman's parish and student ministries today
- Simple to arrange through your IRA custodian
- Allows you to see your generosity at work during your lifetime
